

# **California Transparency in Supply Chains Act Disclosures**

Vital to the success of Appvion, LLC ("Appvion") is the company's commitment to its employees, suppliers, customers, the environment, and the communities in which it operates. As part of that commitment, Appvion is dedicated to following all applicable laws, including complying with the California Transparency in Supply Chains Act, which is designed to eradicate child labor, human trafficking and slave labor. In that regard, Appvion has a **Supplier Code of Conduct** that requires, among others things, that all Appvion suppliers conduct business in the following ways:

- Comply with applicable laws, rules, regulations and Appvion policies.
- Refrain from using child labor and be in compliance with the International Labor Organization, Conventions 138 and 182.
- Guarantee that terms of employment are completely voluntary.
- Refrain from participating in human trafficking, involuntary or slave labor, indebted labor; and refrain from purchasing materials or services from companies using forced, involuntary or slave labor.
- Be able to verify that materials included in their products comply with the slavery and human trafficking laws
  of the country or countries in which they do business.
- Maintain a process and the documentation necessary to demonstrate compliance with Appvion's Supplier
   Code of Conduct and permit Appvion access to the documents for audit and compliance verification
- Confirm that if they are not in compliance, Appvion may request an immediate remediation plan or discontinue the business relationship.

#### **Verification**

Appvion undertakes due diligence prior to conducting business with any supplier. Often, that due diligence includes a visit to the suppliers' headquarters or plant and discussions regarding the supplier sourcing areas. Given Appvion's sourcing partners, Appvion has determined there is a low risk of any of those partners violating any child or slave labor or human trafficking laws. Verification is not conducted by a third-party.

#### **Audits**

As noted above, all Appvion suppliers must agree to maintain a process and the documentation necessary to demonstrate compliance with Appvion's Supplier Code of Conduct and permit Appvion access to documents for audit and compliance verification. Additionally, certain supply relationships are governed by written contracts that provide further audit rights. Audits may be announced or unannounced depending on the circumstances, but it is likely that given the close, open and honest working relationship Appvion has with its suppliers, that audits would be announced. 825 East Wisconsin Avenue P.O. ### **Certifications**

As noted above, as part of the Supplier Code of Conduct, all Appvion suppliers must be able to verify that materials included in their products comply with the slavery and human trafficking laws of the country or countries in which they do business.

## **Accountability**

All Appvion suppliers are required to comply with all applicable laws, including those designed to eliminate human trafficking and child and slave labor. Violation of such laws by any supplier would provide Appvion with contractual rights to terminate the business relationship. Violation of the Supplier Code of Conduct likewise would require a remediation plan or termination of the business relationship.

### **Training**

Appvion's procurement employees receive training to facilitate the Appvion Supplier Code of Conduct and that code continues to be reviewed and discussed at various team and department meetings. Also, Appvion employees are expected to conduct themselves accordance with the Appvion Way – which includes respecting all, which, by definition, includes working to ensure Appvion's business partners do not violate human rights laws.
